The following is the Senate Appropriations Committee hearing schedule for the week of March 26, 2007.

SENATE FLOOR ACTION: The Senate is expected to begin debate on Monday, March 26, 2007, on the fiscal year 2007 supplemental appropriations legislation. The Appropriations Committee on March 22, 2007, approved S. 965 providing \$121.664 billion for the wars in Iraq and Afghanistan, for improving the health care for returning soldiers and veterans, for continued Hurricane Katrina recovery for the Gulf Coast, to fill major gaps in homeland security, and to provide emergency drought relief for farmers.
