4 SEC. 801. For an additional amount for “National
5 Institute of Food and Agriculture, Research and Edu-
6 cation Activities”, \$145,350,000, to remain available until
7 expended.

8 SEC. 802. For an additional amount for “National
9 Institute of Food and Agriculture, Extension Activities”,
10 \$17,000,000, to remain available until expended.

11 SEC. 803. For an additional amount for “Natural Re-
12 sources Conservation Service, Watershed and Flood Pre-
13 vention Operations”, \$100,000,000, to remain available
14 until expended.

15 SEC. 804. For an additional amount for “Rural
16 Housing Service”, \$106,000,000, to remain available until
17 expended.

18 SEC. 805. For an additional amount for “Rural Utili-
19 ties Service, Rural Water and Waste Disposal Program
20 Account”, \$70,000,000 for grants, to remain available
21 until expended.

22 SEC. 806. For an additional amount for “Rural Busi-
23 ness-Cooperative Service, Healthy Food Financing Initia-
24 tive”, \$11,750,000, to remain available until expended.

1 SEC. 807. For an additional amount for “Food and
2 Nutrition Service, Child Nutrition Programs”,
3 \$60,900,000, to remain available until expended.

4 SEC. 808. For an additional amount for “Food and
5 Nutrition Service, Commodity Assistance Program”,
6 \$5,000,000, to remain available until expended.

7 SEC. 809. For an additional amount for “Foreign Ag-
8 ricultural Service, Food for Peace Title II Grants”,
9 \$50,000,000, to remain available until expended.

10 SEC. 810. For an additional amount for “Foreign Ag-
11 ricultural Service, McGovern-Dole International Food for
12 Education and Child Nutrition Program Grants”,
13 \$10,000,000, to remain available until expended.

14 SEC. 811. For an additional amount for “Department
15 of Health and Human Services, Food and Drug Adminis-
16 tration”, \$103,000,000, to remain available until ex-
17 pended.

18 SEC. 812. On page 70 of the bill, strike “; and” and
19 insert a period. Additionally, strike line 10 through “of”
20 on line 17, and insert “SEC. 715. Of”, and strike “; and”
21 on line 20 and insert a period. Strike lines 21–24, and
22 renumber all following general provisions accordingly.

23 SEC. 813. No part of any appropriation contained in
24 this title shall be made available for obligation or expendi-
25 ture, nor any authority granted herein be effective, until

1 the enactment into law of a subsequent Act entitled “Bi-
2 partisan Budget Act of 2015”.
