BILL HIGHLIGHTS

- **Army Corps of Engineers** – \$7.72 billion, \$72 million above the FY20 enacted level and \$1.76 billion above the budget request.
 - For the seventh consecutive year, the bill meets the spending targets in the Water Resources Reform and Development Act of 2014 for appropriations from the Harbor Maintenance Trust Fund for the Corps of Engineers.
 - For the seventh consecutive year, the bill makes full use of the estimated annual revenues from the Inland Waterways Trust Fund to advance American competitiveness and export capabilities.
- **Bureau of Reclamation** – \$1.69 billion, \$10 million above the FY20 enacted level and \$552 million above the budget request, for the U.S. Department of the Interior and the Bureau of Reclamation to help manage, develop, and protect the water resources of Western states.
- **Department of Energy** – \$42.04 billion, \$3.453 billion above the FY20 enacted level and \$6.31 billion above the budget request.
 - *Energy Efficiency and Renewable Energy* – \$2.848 billion, an increase of \$58 million above FY20 enacted and \$2.13 billion above the budget request.
 - *Nuclear Energy Research and Development* – \$1.5 billion for nuclear energy research, development, and demonstration activities, an increase of \$11.9 million above FY20 enacted and \$325.4 million above the budget request. The bill continues funding for the Advanced Reactors Demonstration Program.
 - *Uranium Reserve Program* – \$150 million to initiate the program, the same as the budget request.
 - *Fossil Energy Research and Development* – \$750 million, the same level as FY20 enacted and an increase of \$19.4 million above the budget request.
 - *Office of Science* – \$7.026 billion, an increase of \$26 million above FY20 enacted and \$1.12 billion above the request.

- *Advanced Research Projects Agency - Energy (ARPA-E)* – \$430 million, \$5 million above FY20 enacted levels for ARPA-E to continue to support innovative, advanced research and development projects. The Committee did not adopt the administration’s proposal to terminate this program.
 - *Title 17 Innovative Loan Guarantee Program* – \$29 million for administrative expenses in overseeing and administering the Title 17 Innovative Loan Guarantee Program, the same as FY20 enacted. The Committee did not adopt the administration’s proposal to terminate this program and cancel the remaining credit subsidy and loan authority.
 - *Environmental Cleanup* – \$7.47 billion for DOE environmental management activities and increase of \$78.8 million above FY20 enacted and \$1.5 billion above the budget request. This includes \$6.36 billion for Defense Environmental Cleanup to continue remediation of sites contaminated by previous nuclear weapons production.
 - *Nuclear Security* – \$19.8 billion for DOE nuclear security programs, an increase of \$3.1 billion above FY20 enacted and an increase of \$53 million above the budget request. This includes: \$15.6 billion for Weapons Activities; \$1.68 billion for Naval Reactors; and \$2.1 billion for Defense Nuclear Nonproliferation.
- **Independent Agencies** –
- *Appalachian Regional Commission* – \$180 million, an increase of \$5 million above FY20 enacted and \$15 million above the budget request.
 - *Delta Regional Authority* – \$30 million, the same amount as FY20 enacted and an increase of \$27.5 million above the budget request.
 - *Denali Commission* – \$15 million, the same amount as FY20 enacted and an increase of \$7.7 million above the budget request.
 - *Northern Border Regional Commission* – \$30 million, an increase of \$5 million above FY20 enacted and \$28.15 million above the budget request.
