For an additional amount for "Govern-4 ment Accountability Office, Salaries and Expenses", 5 \$5,300,000; for "Congressional Budget Office, Salaries and Expenses", \$500,000; for an additional amount for 6 7 "Library of Congress, Salaries Expenses", and 8 \$6,000,000; for an additional amount for "Capitol Police, 9 General Expenses", \$3,900,000; and for an additional amount for "Architect of the Capitol, Capital Construction 10 11 and Operations", \$4,300,000, to remain available until 12 September 30, 2022: *Provided*, That upon approval of the Senate and House Committees on Appropriations, the Ar-13 14 chitect of the Capitol may reprogram such additional 15 amounts among any appropriation provided for the Architect of the Capitol. 16
