COMMITTEE ON AGRICULTURE, RURAL DEVELOPMENT, FOOD AND DRUG ADMINISTRATION, AND RELATED AGENCIES

Continuing Appropriations Act, 2022

- Food and Nutrition Service – Appropriated entitlement programs
 - Routine anomaly to allow the Child Nutrition Programs (CNP) and Supplemental Nutrition Assistance Program (SNAP) to continue to serve all eligible participants.

- Rural Development – Rural Micro entrepreneur Assistance Program (RMAP)
 - Provides a loan limitation of **\$25,000,000** to ensure that the program can continue to operate at needed levels and is in compliance with the Federal Credit Reform Act.

- Women, Infants, and Children Cash-Value Vouchers
 - Allows USDA to support the cash-value voucher, which provides fruits and vegetables to low-income mothers and children, during the first quarter of fiscal year 2022.

- Farm Service Agency – Agricultural Credit Insurance Fund
 - Allows FSA to increase the Direct and Guaranteed Farm Ownership loan levels to meet anticipated program demands and avoid anticipated funding shortfalls in these loan categories during the length of the CR.

- Agricultural Marketing Service – Livestock Mandatory Reporting Act Extension
 - Extends the authorization for Livestock Mandatory Reporting through the length of the CR. The authority is set to expire on September 31, 2021.

Disaster Relief Supplemental Appropriations Act, 2022

- Office of the Secretary/Department of Agriculture
 - Includes **\$10,000,000,000** for disaster assistance for producers who have suffered losses due to droughts, hurricanes, wildfires, floods, and other qualifying natural disasters that occurred in 2020 and 2021.

- Natural Resources Conservation Service – Emergency Watershed Protection Program (EWP)
 - Includes **\$275,000,000** in emergency funding for EWP to address damage from 2020 and 2021 disasters, as well as projects in the program backlog.

SUBCOMMITTEE ON COMMERCE, JUSTICE, SCIENCE, AND RELATED AGENCIES

Disaster Relief Supplemental Appropriations Act, 2022

Department of Commerce

- National Institute of Standards and Technology - Scientific and Technical Research Services
 - Includes **\$22,000,000** for building failure investigations required under the National Construction Safety Team Act of 2002.
- National Oceanic and Atmospheric Administration - Operations, Research, and Facilities
 - Provides **\$92,834,000** for calendar year 2020 and 2021 hurricanes and wildfires.
- National Oceanic and Atmospheric Administration - Procurement, Acquisition and Construction
 - Provides **\$52,205,000** for calendar year 2020 and 2021 hurricanes and wildfires.
- National Oceanic and Atmospheric Administration - Fisheries Disaster Assistance
 - Provides **\$200,000,000** for commercial fishery failures and fisheries resource disasters declared by the Secretary of Commerce, including those declared by the Secretary to be a direct result of hurricanes in calendar years 2020 and 2021, for mitigating the effects of commercial fishery failures and fishery resource disasters declared by the Secretary of Commerce.

National Aeronautics and Space Administration

- NASA - Construction and Environmental Compliance and Restoration
 - Provides **\$321,400,000** for repairs at NASA facilities damaged by Hurricanes Zeta and Ida.

National Science Foundation

- National Science Foundation - Major Research Equipment and Facilities Construction
 - Provides **\$25,000,000** for necessary expenses related to the National Science Foundation Regional Class Research Vessel construction impacted by Hurricane Ida.

Legal Services Corporation

- Legal Services Corporation
 - Provides **\$40,000,000** for the Legal Services Corporation to support civil legal assistance related to the consequences of hurricanes, wildfires, other extreme weather, and earthquakes that occurred during calendar years 2020 and 2021.

Afghanistan Supplemental Appropriations Act, 2022

Department of Justice

- Federal Bureau of Investigation - Salaries and Expenses
 - Provides **\$50,000,000** for the FBI's investigative activities associated with Afghan resettlement operations.

SUBCOMMITTEE ON DEFENSE

Continuing Appropriations Act, 2022

- Defense Working Capital Fund
 - Allows the Department to continue to provide working capital fund services and products ordered by HHS pursuant to the COVID-19 pandemic.
- Procurement -- Defense-Wide – Military Global Positioning System User Equipment Procurement
 - Provides the funding necessary to procure Military Global Positioning System User Equipment system requirement.
- Procurement -- Defense-Wide – Iron Dome defense system
 - Provides **\$1,000,000,000** to replenish Israel’s Iron Dome defense system following the May 2021 conflict between Israel and Hamas when more than 3400 rockets were fired towards Israel. These funds will provide critical support to Israel’s defense and help ensure the future security of a key ally.
- Other Procurement -- Air Force – Strategic Microelectronic Supply
 - Provides funding at an annual rate of **\$855,000,000** to support the program which relies on equipment that will no longer be available at the end of FY22.

Disaster Relief Supplemental Appropriations Act, 2022

- Operation and Maintenance -- Navy
 - Provides **\$565,000,000** for facility damage incurred from severe storms, straight-line winds, flooding, tornadoes, earthquakes, wildfires, and hurricanes during 2020 and 2021.
- Operation and Maintenance -- Air Force
 - Provides **\$330,000,000** for facility damage related to the consequences of Winter Storm Uri.

Afghanistan Supplemental Appropriations Act, 2022

- Overseas Humanitarian, Disaster, and Civic Aid
 - Provides **\$2,200,000,000** for U.S. military costs associated with the relocation of individuals from Afghanistan, temporary housing and shelter, etc. as part of Operation Allies Welcome.
- Afghanistan Security Forces Fund
 - Authorizes payment of costs associated with the termination of previous contracts funded by the Afghanistan Security Forces Fund account.

- General Provisions
 - Prohibits the funding provided from being subject to transfer authority.
 - Requires a written report on the obligation of resources provided to DOD for these purposes and any transferred to the Department by another Federal agency.
 - Requires the IG to carry out reviews of the activities of DOD to transport and care for Afghans.

SUBCOMMITTEE ON ENERGY AND WATER DEVELOPMENT

Continuing Appropriations Act, 2022

Department of Interior

- Bureau of Reclamation
 - Extends the authority for the Calfed Bay-Delta Authorization Act and various Bureau of Reclamation authorities to continue drought emergency response activities.
- Bureau of Reclamation -- Water and Related Resources
 - Provides authority to expend funds previously appropriated and makes prior year funding available for specified Water Infrastructure Improvements for the Nation (WIIN) Act projects.

Department of Energy

- Uranium Enrichment Decontamination and Decommissioning
 - **\$841,000,000** from the United States Enrichment Corporation (USEC) Fund is transferred into the Uranium Enrichment Decontamination and Decommissioning (UED&D) Fund to allow work to continue at sites during the duration of the Continuing Resolution.

Disaster Relief Supplemental Appropriations Act, 2022

Corps of Engineers

- Investigations Account
 - Provides **\$100,000,000** for resiliency funding for completion, or initiation and completion of flood and storm damage reduction studies to reduce risk from future floods and hurricanes.
 - Storms Covered: Hurricane Ida
- Construction Account
 - Provides **\$3,000,000,000** for resiliency funding to construct flood and storm damage reduction projects, including shore protection. Of this amount, **\$1,500,000,000** is available for States with a major disaster declared due to Hurricane Ida.
- Mississippi River and Tributaries Account
 - Provides **\$868,000,000** for resiliency funding to construct flood and storm damage projects in States with a major disaster declared due to Hurricane Ida and an additional **\$368,000,000** to repair damages to Corps of Engineers projects, caused by natural disasters.

- Operation and Maintenance Account
 - Provides **\$887,000,000** in damage funding for necessary expenses to dredge Federal navigation projects in response to, and repair damages to Corps Federal projects caused by, natural disasters, including those from Ida.
- Flood Control and Coastal Emergencies Account
 - Provides **\$826,000,000** for necessary expenses to prepare for flood, hurricane, and other natural disasters and support emergency operations, repairs, and other activities in response to such disasters.
- Expense Account
 - Provides **\$30,000,000** for necessary expenses to administer and oversee the obligation and expenditure of amounts provided for the Corps.

Department of Interior

- Central Utah Project Completion Account
 - Provides **\$10,000,000** for use by the Utah Reclamation Mitigation and Conservation Commission for expenses necessary in carrying out fire remediation activities for 2018 wildfires.
- Bureau of Reclamation -- Water and Related Resources
 - Provides **\$210,000,000** for activities to address drought and **\$10,000,000** for fire remediation and suppression emergency assistance related to wildfires in 2019, 2020, and 2021.

Department of Energy

- Energy Programs -- Strategic Petroleum Reserve
 - Provides **\$43,000,000** to address hurricane-related damages resulting from Hurricanes Laura, Delta, Harvey, and Ida that impact the Strategic Petroleum Reserve's (SPR) ability to perform its mission of protecting the U.S. economy and its ability to ensure the safety and security of its workforce.

SUBCOMMITTEE ON FINANCIAL SERVICES AND GENERAL GOVERNMENT

Continuing Appropriations Act, 2022

- Executive Office of the President -- White House Salaries and Expenses
 - Provides **\$60,000,000** additional funding relating to operational support for COVID-19 testing and other health safety requirements.
- General Services Administration -- Allowances and Office Staff for Former Presidents
 - Provides **\$5,000,000** for the statutorily-required pension and office support costs of former Presidents. The language is similar to that previously enacted in years that follow presidential transitions.
- Small Business Administration -- Business Loans Program
 - Provides SBA the authority to accommodate demand increases for business loan programs during the period of the continuing resolution.
- District of Columbia -- Pre-Trial Services Agency
 - Provides **\$70,574,000** for the District of Columbia (D.C.) Pretrial Services Agency to increase staff and acquire additional Global Position System monitoring devices due to increased court processing times for defendants in D.C. awaiting trial as a result of the COVID-19 pandemic.
- District of Columbia -- D.C. Local Funds
 - Provides the D.C. the authority to spend funds received from local tax revenues and other non-Federal sources in FY 2022.
- The Judiciary - Administrative Office of the U.S. Courts
 - Technical corrections to the Bankruptcy Administration Improvement Act of 2020 (P.L. 116-325) to allow chapter 7 trustee compensation payments to be made in instances where a case is filed in one fiscal year, but the case trustee's services are not provided until the following fiscal year.

Disaster Relief Supplemental Appropriations Act, 2022

- Small Business Administration -- Disaster Loans Program Account
 - The bill provides **\$1,189,000,000**, of which **\$620,000,000** is for administrative expenses so that the Small Business Administration may cover the cost of disaster loan subsidies and administrative expenses that result from Hurricane Ida.

SUBCOMMITTEE ON HOMELAND SECURITY

Continuing Appropriations Act, 2022

- Customs and Border Protection -- Operations and Sustainment
 - Provides **\$840,000,000** for supplemental support to Customs and Border Protection at an annualized rate to offset fee revenue shortfalls for the Office of Field Operations.
- U.S. Citizenship and Immigration Services
 - Authorizes USCIS to establish an account for the purposes of application processing, reduction of backlogs within asylum, field, and service center offices, and support the refugee program, and to spend at an annualized rate of **\$250,000,000** for such purposes.
- FEMA -- Disaster Relief Fund – DRF Apportionment Flexibility
 - Makes **\$17,142,000,000** (same as FY21 funding level) immediately available for the Disaster Relief Fund (DRF for disaster response and recovery activities under the Stafford Act).
- National Flood Insurance Program – Authorization Extension
 - Provides an extension of NFIP authorization, which would otherwise expire on September 30, 2021. Allows the NFIP to sell or renew flood insurance policies during the period of the CR.

Disaster Relief Supplemental Appropriations Act, 2022

Federal Emergency Management Agency

- Federal Assistance -- Emergency Management Performance Grants (EMPGs)
 - Provides **\$50,000,000** for formula grants that support all hazard emergency management capability investments for State, Local, Tribal, and Territorial governments.
- Disaster Relief Fund Loan Cancellation
 - Cancels the remaining balances of all outstanding loans for the Community Disaster Loans program, and provides that such sums as necessary may be transferred from the DRF to the Disaster Assistance Direct Loan Program to carry out such loan cancellations.

Afghanistan Supplemental Appropriations Act, 2022

- U.S. Citizenship and Immigration Services -- Immigration Examination Fee Account
 - Provides **\$193,000,000** for USCIS, which may only be used in connection with Operation Allies Welcome to adjudicate the immigration status of Afghan evacuees including necessary reimbursements to the State Department and FBI.

- Afghan Parolee Immigration Status
 - Establishes how Afghans evacuees, after vetting, can be paroled into our country and provides them with refugee-level assistance for 18 months. Expedites the process for eligible Afghans to seek asylum under existing law while making it clear that their temporary refugee benefits do not include a new path to citizenship. Imposes reporting requirements on the administration to explain to Congress and the American people who the Afghan evacuees are.

SUBCOMMITTEE ON INTERIOR, ENVIRONMENT AND RELATED AGENCIES

Continuing Appropriations Act, 2022

- Department of the Interior -- National Park Service – National Heritage Areas Extension and Cap Increases
 - Continues authorization for the period of the CR for 30 National Heritage Areas and Commissions that expire on September 30, 2021.
- Indian Health Service -- Indian Health Services – Staffing for New Facilities
 - Provides an additional **\$24,341,000** above the fiscal year 2021 enacted level for staffing newly constructed or expanded facilities and will allow the Indian Health Service to operate new facilities without reducing current direct patient care services.
- Department of the Interior and Forest Service -- Great American Outdoors Act Land and Water Conservation Fund (LWCF) – Administrative Funds
 - Allocates funding for administrative activities associated with LWCF programs for the period of the CR for the Bureau of Land Management, Fish and Wildlife Service, National Park Service, and Forest Service.

Disaster Relief Supplemental Appropriations Act, 2022

Overall, the bill provides **\$1,775,850,000** (breakout below) for response to natural disasters, including several hurricanes and recent devastating wildfires. Funds provided are focused on rehabilitation and recovery of public lands and assets and assistance to states for fire assistance and disaster response. Also includes a provision to ensure wildland firefighters are paid for all of their hours on duty.

Department of the Interior

- Bureau of Land Management -- Management of Lands and Resources
 - Provides **\$1,192,000** for repair and rehabilitation of facilities and hazardous materials cleanup in response to calendar year 2019, 2020, and 2021 wildfires, hurricanes and other natural disasters.
- Fish and Wildlife Service -- Construction
 - Provides **\$58,227,000** for repair, rehabilitation, and replacement of roads, bridges, levees, dikes, and water control structures as well as trails, campgrounds, and other recreation and administrative assets in response to calendar year 2019, 2020, and 2021 wildfires, hurricanes and other natural disasters.
- National Park Service -- Construction

- Provides **\$229,472,000** for repair, rehabilitation, and reconstruction of Park Service facilities and assets damaged or destroyed by extreme weather events.
- U.S. Geological Survey -- Surveys, Investigations, and Research
 - Provides **\$26,284,000** for repair, rehabilitation, and replacement of levees, dikes, water control structures, and other mission critical equipment and assets in response to calendar year 2019, 2020, and 2021 wildfires, hurricanes and other natural disasters.
- Bureau of Safety and Environmental Enforcement -- Offshore Safety and Environmental Enforcement
 - Provides **\$223,000** for response to damages to agency assets incurred as a result of Hurricane Ida.
- Bureau of Indian Affairs -- Construction
 - Provides **\$452,000** for repair and rehabilitation of facilities, roads, and bridges in response to calendar year 2019 hurricanes and other natural disasters.
- Wildland Fire Management
 - Provides **\$100,000,000** for stabilization and restoration of burned areas and fuels mitigation in response to calendar year 2019, 2020, and 2021 wildfires.

U.S. Forest Service

- Forest Service Operations
 - Provides **\$105,000,000** for agency-wide needs related to implementation of disaster response and recovery activities in response to 2019, 2020, and 2021 wildfires, hurricanes and other natural disasters.
- Forest and Rangeland Research
 - Provides **\$25,000,000** for State Forest Inventory and Analysis research and support in response to 2019, 2020, and 2021 wildfires, hurricanes and other natural disasters.
- State and Private Forestry
 - Provides **\$50,000,000** for grants to states for fire assistance and recovery efforts following natural disasters in response to 2019, 2020, and 2021 wildfires, hurricanes and other natural disasters.
- National Forest System
 - Provides **\$710,000,000** for public lands rehabilitation, including: watersheds and critical habitat; invasive species and insect outbreak prevention, suppression, and recovery; and hazardous fuels management in response to 2019, 2020, and 2021 wildfires, hurricanes and other natural disasters.

- Capital Improvement and Maintenance
 - Provides **\$470,000,000** for repair, rehabilitation, and replacement of roads, trails, bridges, equipment, and facilities damaged or destroyed by disasters in response to 2019, 2020, and 2021 wildfires, hurricanes and other natural disasters.

SUBCOMMITTEE ON LABOR, HEALTH AND HUMAN SERVICES AND EDUCATION AND RELATED AGENCIES

Continuing Appropriations Act, 2022

Department of Health and Human Services

- Centers for Disease Control and Prevention – Vessel Sanitation
 - Provides **\$1,500,000** for one-time funding for FY2022 to support the vessel sanitation program to replenish depleted user fees.
- National Institutes of Health – Grant Extension
 - Allows NIH one additional year to disburse funding provided for five year grants incurred in fiscal year 2016. This authority was also provided in fiscal year 2020.
- Substance Abuse and Mental Health Services Administration – National Suicide Prevention Lifeline
 - Provides **\$77,600,000** in additional funding to support the national suicide prevention lifeline’s network and operations as it transitions to three digits (9-8-8) in July 2022.
- Office of the Secretary – Commissioned Corps
 - Extends authority for members of the Commissioned Corps to carry over annual leave balances in excess of the 60 days allowed under current law. This authority was also provide to the Commissioned Corps in fiscal year 2020.

Administration for Children and Families

- Unaccompanied Alien Children (UAC)
 - Provides **\$2,500,000,000** in additional funding for the Office of Refugee Resettlement (ORR) to care for UACs referred to ORR; requires a report on ending the use of Emergency Intake Sites and a spend plan for fiscal year 2022, and requires monthly reports on all obligations and expenditures. Without additional funding, ORR will enter into deficiency status.
- Refugee and Entrant Assistance
 - Allows ACF to obligate funding in the Refugee and Entrant Assistance account as necessary to care for UACs referred to HHS and provide services for refugees.
- Report on UACs Released to Sponsors
 - Requires the Secretary of HHS to provide a report on the number of unaccompanied children released to sponsors in the United States, including the number of children where ORR has successfully conducted safety and welfare checks.

- Report on UACs
 - Requires the Secretary of HHS to provide a report to Congress, and disclose online, on funding transfers to the UAC program in fiscal year 2021 and for fiscal year 2022 and information on children referred to ORR.
- Community Services Block Grant
 - Extends the authority provided in the CARES Act to authorize states to revise the income limit for eligibility from 125 to 200 percent of the federal poverty limit for Community Services Block Grant services furnished during the period covered by the CR.
- TANF Extension
 - Extends the authorization of the Temporary Assistance for Needy Families program through the period of the CR.

Department of Education

- National Advisory Committee on Institutional Quality and Integrity (NACIQI)
 - Extends the authorization for NACIQI, which expires on September 30, 2021, through the length of the CR.
- Account Maintenance Fees
 - Extends the authority for payments for administrative costs to student loan guaranty agencies in the Federal Family Education Loan program, which expires on September 30, 2021, through the length of the CR.

Afghanistan Supplemental Appropriations Act, 2022

Department of Health and Human Services

- Centers for Disease Control and Prevention
 - Provides **\$21,500,000** in supplemental funding to support vaccine delivery, medical screening and support, and related public health activities for Afghan arrivals and refugees.
- Administration for Children and Families -- Refugee and Entrant Assistance
 - Provides **\$1,680,000,000** in supplemental funding for refugee and entrant assistance activities, including cash and medical assistance, in support of citizens or nationals of Afghanistan paroled into the United States and otherwise eligible Afghans.
- Administration for Children and Families -- Children and Families Services Programs
 - Provides **\$7,773,000** in supplemental funding for administrative expenses to carry out refugee and entrant assistance activities in support of citizens or nationals of Afghanistan.

- General Provision -- Report on Afghan Evacuee Resettlement
 - Requires the Secretary of HHS, the Secretary of State, and the Secretary of Homeland Security to jointly submit a strategy on Afghan evacuee resettlement.

SUBCOMMITTEE ON LEGISLATIVE BRANCH

Continuing Appropriations Act, 2022

- Continuing the Member Pay Freeze
 - Continues the Member pay freeze.

SUBCOMMITTEE ON MILITARY CONSTRUCTION AND VETERANS AFFAIRS

Continuing Appropriations Act, 2022

- Department of Defense -- Military Construction Army, Air Force, and Defense-Wide
 - Provides an exception to current law to allow for obligations into the 6th year to allow projects to award during the CR period.

- Department of Veterans Affairs -- Veterans Benefits Administration—General Operating Expenses, Departmental Administration—Board of Veterans Appeals, and Departmental Administration—Information Technology Systems
 - Provides **transfer authority up to \$193,500,000** of existing funding to implement a new rule regarding new conditions for which service-connection is now presumed.

SUBCOMMITTEE ON STATE, FOREIGN OPERATIONS, AND RELATED PROGRAMS

Continuing Appropriations Act, 2022

- United States Agency for Global Media, The Asia Foundation, United States Institute for Peace, and the National Endowment for Democracy
 - Provides authority to apportion funds for certain entities to support the evacuation of at-risk Afghans employed by such entities.
- Department of State, Diplomatic and Consular Programs
 - Extension of certain passport and visa security fee authority to help cover the cost of providing consular services.
- United States Development Finance Corporation (DFC)
 - Authority for the DFC to use appropriated funds to modify legacy loans and loan guarantees previously managed under the Overseas Private Investment Corporation. Authority exists to use fiscal year 2019 funds for such purposes, which expire at the end of fiscal year 2021.
- United States Advisory Commission on Public Diplomacy
 - Extension of authorization of the Commission through the duration of the CR.

Afghanistan Supplemental Appropriations Act, 2022

Department of State

- Emergencies in the Diplomatic and Consular Service
 - Provides **\$276,900,000** for support for Operation Allies Welcome and related efforts by the Department of State, including additional relocations of individuals at risk as a result of the situation in Afghanistan and related expenses, and to reimburse the account.
 - Provides **\$400,000,000** to address humanitarian needs in Afghanistan and the region impacted by the situation in Afghanistan.
- Migration and Refugee Assistance
 - Provides **\$415,000,000** to address humanitarian needs in, and to assist refugees from, Afghanistan.
- United States Emergency Refugee and Migration Assistance Fund
 - Provides a total of **\$1,076,000,000**, to include **\$976,100,000** to support Operation Allies Welcome and related efforts by the Department of State, including additional relocation of individuals at risk as a result of the situation in Afghanistan and related expenses; and **\$100,000,000** to respond to other unexpected and urgent humanitarian emergencies.

- General Provisions
 - Provides authority for the Department of State and United States Agency for International Development to hire Afghan nationals who worked for such agencies in Afghanistan without geographic limitations during fiscal years 2022 and 2023.
 - Requires a report not later than 45 days after enactment of the Act and every 45 days thereafter until September 30, 2023 on proposed uses of funds appropriated under the Emergencies in Diplomatic and Consular Service and United States Emergency Refugee Migration and Assistance Fund headings.
 - Requires a report not later than 45 days after enactment of the Act regarding Priority 2 (P-2) designations granting United States Refugee Admissions Program access for certain at risk Afghan nationals and their eligible family members.
 - Prohibits funds appropriated by this title and made available for assistance for Afghanistan may be made available for direct assistance to the Taliban.

SUBCOMMITTEE ON TRANSPORTATION, HOUSING AND URBAN DEVELOPMENT, AND RELATED AGENCIES

Continuing Appropriations Act, 2022

- Department of Transportation – Essential Air Service
 - Provides **\$247,000,000** for the payments to Air Carrier account and authority to obligate this funding at a rate for operations necessary to maintain the Essential Air Service (EAS) program at current levels.

- Department of Housing and Urban Development – Title VI of the Native American Programs
 - Includes a loan limitation to be apportioned up to the rate necessary to continue program activity to avoid delays in loan closings, increased transaction costs, and loss of project funding sources.

Disaster Relief Supplemental Appropriations Act, 2022

Department of Transportation

- Federal Aviation Administration Facilities & Equipment
 - Provides **\$100,000,000** to repair and replace FAA facilities and equipment damaged or destroyed due to Hurricane Ida.

- Federal Highway Administration
 - Provides **\$2,600,000,000** for the Highway Emergency Relief Program to respond to unmet needs resulting from (pre-Ida) natural disasters that occurred in calendar year 2020 and most of 2021 (does not include anticipated needs stemming from Hurricane Ida).

Department of Housing and Urban Development

- Community Development Block Grant – Disaster Relief
 - Provides **\$5,000,000,000** for qualifying disasters in 2020 and 2021 to provide funding for long-term recovery needs including rebuilding housing, the restoration of infrastructure, and economic development.
